Area Report for Region held in Geneva

Dear Area body,

The regional body is growing in participation and we only have 1 position which needs to be filled and that is Regional H&I Coordinator, let me know if we have anyone interested in this position. This position would link all the area H&I subcommittees in our region with the goal of working together to broaden the coverage of our H&I committees.

We finalized our voting at region this month and Gribril was voted in for RD as his nomination was tabled at last region. Mike A. was voted in for regional secretary and Dennis was voted in for PR, he will now be regional PR and Lit.

There was one significant aspect discussed during area reports and that was, HONYAN or Heart of New York the Syracuse area, will only be holding its convention bi-annually from now on and the next convention will be in 2020.

Old-Business:

There was a work conflict and the members who were supposed to meet to transfer the banking account were not able to meet. We voted to wait for all the outstanding checks: NAWS donation, Check to Dennis for NEZF donation, and payment for the po box, to clear the bank account and a blank check was written to allow Kate to open an account at M&T at such time.

New Business:

\$100 check written to Alif for NEZF donation returned to Kate as he was unable to attend due to family emergency and written to Dennis as reimbursement for his out of pocket donation. Subsequently, here after the donations to NEZF will be written to the Vice-Chair directly as there is no Zone checking account at this time.

Finger lakes requested region switch to a consensus-based decision making forum again and was voted no as discussed at last regional meeting.

Clarification of bylaws: regional meeting is suppose to start at 12:30 pm and we will be making sure this happens for our next meeting January 20th.

Discussion about Zonal Forum to be held in Rochester - possibly the Radisson @ Rochester Airport Next NEZF Zoom meeting 12/16 at 3 or 4 pm

Votes conducted for Zonal Forum

Proposal 1: Financial responsibility- **Voted Yes** to put duties under the responsibilities of Vice Chair Alternative option was to create separate treasurer or financial overseer, funds are generally limited and participation not feasible.

Tabled vote to opening a checking account for Zone. Money is now handled in cash by the Vice-Chair. Discussed pros and cons logistically not feasible at this time. Difficult enough to switch signers and bank at the regional level, would be more difficult to do at Zone level.

Proposal 2: **Take back to areas-** Amend NEZF guidelines to evolve/expand zonal responsibilities shifting from a discussion forum to an actual service structure to assist areas and regions more effectively.

Proposal 3: **Voted Yes** to formalizing AD HOC Zonal PR- to make an actual ZONAL PR Committee

Ad Hoc meeting is Tuesday nights at 9 pm. Which Tuesday varies however can put you in contact with Dennis if you would like more information.

Voted Yes to hosting the NEZF 6 months early, Dennis volunteered to be point of contact however, received email that RD Gibril and RDA Alif will be the points of contact for the event.

Recovery by Mail: Rebecca B. still needs male writer for inmates. Discussed possible Zoom meeting to boost participation.

A&E: Becka M. expressed difficulty contacting area A&E chairs, was given some contact information and discussed plan to overcome this obstacle.
